## About the speakers

### **Professor Roberto Martina**

Roberto Martina graduated *cum laude* in Medicine and Surgery in 1972. He has got the degree of specialist in Dentistry in 1974 and of specialist in Orthodontics in 1978. He had been assistant professor in Orthodontics since 1978, associate professor since 1980, and full professor since 1987. Since 1988, he is the chairman of the postgraduate program in Orthodontics at the University of Naples Federico II. He has been Dean of the same Dental School from 2002 to 2005. He has been President of Italian Society of Orthodontics in 1990 and 1991, president of European Orthodontic Society in 2001-02, and president of the European Federation of Orthodontics in 2005-06.

### **Professor Sergio Paduano**

Sergio Paduano graduated in Medicine at the University of Naples Federico II in 1981. He is specialist in Otolaryngology, Dentistry, and Orthodontics. He has been senior clinical lecturer at the postgraduate school in Orthodontics of the University of Naples Federico II, His main research and clinical interests are focused on straightwire, bioprogressive, and segmented techniques in orthodontics. He is a certified member of the Italian Board of Orthodontics and European Board of Orthodontics. He has given many lectures and clinical courses in Italy, and has published in international and Italian journals. Since 2005, he is a research professor at the Faculty of Medicine, Oral Sciences at the University of Magna Graecia, Catanzaro, Italy.

**Professor Ambra Michelotti**

Ambra Michelotti graduated in Dentistry (DDS) in 1984. In 1991 she's got the degree of specialist in Orthodontics and since then she has been teaching in undergraduate and postgraduate courses in Orthodontics at the University of Naples Federico II. Since 2001, she is an associate professor in Clinical Gnathology. She has authored or co-authored more than 100 papers published in Italian and international journals. Ambra Michelotti is an internationally recognized expert in the field of temporomandibular disorders and has given numerous lectures and courses in different countries. She is an associate editor of the European Journal of Oral Sciences and has been elected president of the European Academy for Craniomandibular Disorders for 2010.
